\* Funding covers a portion of energy costs; it is not intended to pay your entire energy bill. How much funding you receive depends on several factors, including your income, size of your home or apartment, and energy costs. (In most cases, the annual Energy Assistance monetary benefit will be paid directly to your energy supplier.)

## WHAT TO HAVE READY:

**PHOTO ID** (mandatory for first-time applicants)

**SOCIAL SECURITY NUMBERS AND DATES OF BIRTH** for everyone in the household.

**CURRENT GAS, ELECTRIC, OIL OR UTILITY BILL**

- Customers with heat included must provide landlord's contact information and the current lease or a letter from the landlord.
- Rent Assistance recipients must provide proof of rent, amount of rent assistance and utility allowance.

**PROOF OF INCOME FOR ALL HOUSEHOLD MEMBERS**

- Gross income for ONE MONTH prior to the application month is required. This includes wages, SSA benefits, pension, unemployment benefits etc.
- Self-generated or seasonal income requires tax documents from the most recent filing year. Examples: Landscaping, snowplowing, school bus drivers, Uber/Lyft drivers, rental property. Includes Partnerships, LLCs and corporations. If you cannot provide valid taxes, gross income will be counted.
- Recurring payments (ex. interest, dividends or royalties) must be verified with tax documents or statements.
